- MATCH 4...2 SS, 20 SHOTS PRONE SLOW FIRE 20 MINUTES FOR RECORD**
- MATCH 5...RAPID FIRE AGGREGATE (MATCHES 2 AND 3)**
- MATCH 6...SLOW FIRE AGGREGATE (MATCHES 1 AND 4)**
- MATCH 7... GRAND AGGREGATE (MATCHES 1 THROUGH 4)**
